Peter Read was transported to Chas. Cty., VA by 1654 by Walter Brookes. 23 June 1635, George Brookes, age 35 (a headright of WM. Barker) and sons William Brookes, age 17, and Walter Brookes, age 15 along with a Steeven Read, age 24 and Richard Young, age 31 came from London to VA by certificate from Minister of Gravesend. (Pub. Records Office E157/20). Could there be a connection between this young Walter Brooks and is the Steeven Read who came over with him any relation to Peter Read. Seems strange that young Walter Brooks came over with Steeven Read and then was a headright Walter Brooks came over with Steeven Read and then was a headright for Peter Read Is there a connection between Steeven Read and Peter Read? Then there is the business of the Richard Young that came with Steeven Read Peter Read's dau. Ann married a Porrell Young. Any connection there?

In 1665, Peter was serving on a jury.

At a court held at Westover, VA 4/3/1688 Ann Read was granted admin. of estate of her late husband, Peter Read; Ben Traverse, Sec. (P118, Chas. Cty., VA Court Records 1682-1695). At a court held at Westover 10/2/1688, page 155, Ann Read, admin. of Peter Read, deed., James Walks & Edmund Irby to inventory estate.
