

The Read Family

First Generation

M. Ann (-?-) Read. B. Peter Read was in Charles City County by 1654 indentured to Walter Brooks. As a matter of history he was transported to Charles City by Walter Brooks, 23 June 1635. In the group were George Brookes, age 35, (a headright of Wm Barker) and sons William Brookes, age 17, along with a Steeven Read, age 24 and a Richard Young, age 31. They came from London to VA by certificate from Minister from Gravesend. This can be found in Public record s Office E157/20. Is there a connection between Steeven Read and Peter Read? As you can see Richard Read came with Steeven Read, and Peter Read's daughter, Ann married a Dorrell Young.

We find his name on early court records. In 1655 his name was on a jury list from Merchants Hope, now known as Prince George. In 1685 his daughter Ann died. She was the widow of Dorrill Young and had four children. On April 3 1688 Peter's wife also named Ann, was granted the administration of her late husband's estate, so by then Peter had died. This record may be found at Westover 10/02/1688, page 135, "Ann Read, admin., of Peter Read, dec'd., James Wallis and Edmund Irby to inventory estate.

All of the forgoing information has been supplied by Helen Tice a family descendant and researcher from Memphis TN.

In 1694 Henry Read was in court trying to protect the interests of the children of his late sister, Ann Young. Joan Young orphan of Ann Young age 15, chose Henry Harmon as her guardian. Who was he? This must have been a close relationship. After all her Uncle Henry Read was living and she could have chosen him. The order books of Charles City County refer to Henry Harmon many times. Perhaps Ann, wife of Peter Read was a daughter or a sister of Henry Harmon. And was this Henry named for Henry Harmon? And perhaps Harmon Read, Henry's son was named for Henry Harmon. And in 1693 Henry served on a grand jury at Westover, Westover Parish. Prince George County.

Also Henry Read has 75 acres in Prince George County Virginia in 1704. (as proven by the "Rent Roll of all the lands held in the County of Prince George for the year 1704") This information has been researched and supplied by Helen Tice a researcher from Memphis TN. It is her hope that further documents will be located to tell us more about the early beginnings of the Read family.

In Deed Book 10 -1453 (439,440,441,442) Mary Read, widow of Halifax County, on 17 Aug 1769 gives to Aaron Read Pendry "54 pounds of proclamation money and a negro woman, to son Moses Read Pendry, planter "for love and good will and affection" a negro boy and with the heading she sives negroe persons to Lydia Read and Jesse Read Pendry. Each time the witnesses were Thomas Neville and two of the other persons not mentioned in the deed, thus, James Pendry, Jesse Read Pendry, Lydia Read and AAron Read Pendry. Harmon Read had died in 1767. It is interesting to note the names with sometimes Read and sometimes Pendry used as a surname

Harmon had his will probated October 1767 in ---. 11

Helen Tice, a researcher from Memphis TN, and descendant of Harmon Read writes the following in her story, My Mississippi Roots: "In Prince George Co VA on 11 March 1716, Harmon Read leased to Michael Wallace of the same county, 75 acres on which Harmon formerly lived in the parish of Westopher, on the North side of Stackwater Swamp. Wallace was to pay Read four £. Harmon's wife Ann, relinquished her dower right." and to continue, Helen writes: "Because so many of the county records in this area of VA have been destroyed, either by war, fire, flooding etc this is the first record of Harmon Read that has been found. It does prove however that for him to have been married and selling land, he had to have been 18 years old. Therefore it can be said with some certainty that he was born by 1698.

*Harmon bought land in Isle of Wight Co VA as early as 1730, when he purchased 415 acres on Roasting Ear Branch from William and Hugh Lee. Tobacco was the important crop in Tidewater VA at that time, so it's likely that a portion of his land was given over to the cultivation of tobacco.

With his second wife, Mary Pendry, Harmon moved his family from VA to Edgecombe Co NC. By 1749 they had purchased land on Beaver Dam Swamp. In 1758 Halifax Co was formed from Edgecombe Co and Harmon and his family found themselves living in the newly formed county of Halifax. He lived there until his death in 1767.

In Deed Book 9 of the Deeds of Halifax County, NC 1758-1771, 1099-(349) we find that Harmon Read and his wife Mary of Halifax County deed to their son Jesse Read Pendry on 27 MAy 1765 for "natural love and affection" and 5 shillings, 237 acres on the south side of Beaverdam Swamp, joining Moses Pendry, John Pritchett, Braswell Hewitt. Witnesses: Moses Read Pendry, Read Pendry and Richard Freear.

The information on Harmon's family has been presented by Helen Tice in her work

"Read My Roots".

Moses Read was a private in Capt Benjamin Coleman's Company, of the Second North Carolina Battalion. He was stationed at White Plains NY about 9 Sept 1778, as was his brother Jesse. Story written in John S. Polk'sJesse Read Patriot-Preacher. His term of enlistment was for three years. (Ref. Roster of Soldiers from NC in the American Revolution. DAR 1932 p305.

According to Helen Tice, sometime around 1802/3, Moses moved his family from Halifax Co NC to TN. He settled in a part of Dickson Co that later became Robertson Co where he died in 1815/16. He left no will, but his children were named in a Feb 1816 deed: "The Heirs of Moses Read". His wife was not mentioned so we can assume she had already died... The name of his wife is not known.

An article in "The Dictionary of North Carolina Biography" vol 5 P-S tells us about Jesse and his family.

His father Harmon bequeathed land to Jesse in Halifax County NC thus making

Jesse the holder of the family plantation.

Early in the Revolution on Oct 20 1776 Jesse entered the Sixth N.C. Regiment with the rank of second lieutenant. He advanced to first lieutenant on Oct 25 1777 and then to captain on Oct 15 1781. He received bounty land warrant for his swrvice and he later sold this to Henry Wiggins.

The name of his wife is uncertain, but there is evidence to believe that it was Charlotte Smith. Joel Smith in his will mentioned "my daughter Charlotte Read." Jesse

Read and Joel Smith had adjoining lands.

One of Jesse Read's sons named Rhesa was married first to Mary Carstarphen, then secondly to Mary Sutherland. The daughter of the second marriage, Nancy Carolina "Ann" Read, was born 1821 in Halifax Co NC, m. Major Frank Hawkins in 1835/36 in Halifax Co NC and died 4 July 1897 in MS. She is buried near her mother Mary R Sutherland Read in Winona MS.

MS. " John was listed as the head of a family on the 1860 Census in Edwards Depot, John was listed as the head of a family on the 1870 Census Winona, CARROLL MS.

Picture of John Read (in Book 1 pg 2) supplied by Helen Tice of Memphis TN John Read served in the War of 1812 and applied for a Pension on 10 April 1871 Claim No. 8859 Enlisted at MONTGOMERY TN 28 Jan 1814 Discharged 28 May 1814 served in Capt. Haggard's Co. TN Militia, 121 days, mounted infantry and supplied his own horse, and performed his whole duty as a soldier at the Battle of Horse Shoe Bend, fighting the Creek Indians led by Chief Red Eagle. On claim John Read is listed as seventy-seven years old a resident of CARROLL MS, was married to Dicey T Duke, now dead, at MONTGOMERY TN on 4 Jan 1816. Served in the indian war (sic) under Gen'l Jackson and was honorably discharged at Fayetteville TN. At this time he was living in CARROLL MS near Winona.

The following information is supplied by fellow researcher Helen Tice of Memphis TN. "John Read, son of William and Rebecca Read was born in Halifax Co NC in 1794. John went with his family to TN and spent his early years in Dickson Co TN with his 8 brothers and sisters. After his military service in the War of 1812 (as listed above, for which he received an \$8.00 a month pension!) he married Dicy T. Duke in Mongomery Co TN in 1816. In the early 1820's, the Read family moved to AL. Land office records at Cahawba reflect that in Nov 1820, John Read purchased 4 Clairborne AL town lots. (filed Book 1 #4) But, by 1828 the family was to move again, this time to MS. Land records from Tuscaloosa County TN show that John Reid (sic) and Dicey Reid sold property to Felix Houpt 4 Dec 1827 Bk. F p243, and to John Huit 4 Dec 1827 k F p244. (copy Book 1 #5) John settled with Dicey and their 7 children in Madison Co MS. They moved later to Hinds Co near Edwards MS where they became members of Old Liberty Church. They were followed to MS by John's brother Lemuel and his wife Mary.

John Read was much opposed to the secession of the states from the Union. For this reason Northern Soldiers, during the Civil War favored him by not burning his house. But they did burn his gin house in which he had stored the cotton from three year's crops. They took all of his slaves, his horses, mules, cattle, sheep, hogs and chickens. Many of the family's hogs had been left hidden in the woods, and they were the only means of food, except for what Dicey Read had hidden away. Cavalry horses

were turned into the gardens, orchards, and into the growing crops.

As the family were now "prisoners of the Army of the north", they had to draw rations from the army commissary just as the soldiers did. Each Saturday, John, who was too old for service in the war, went into the enemy's camp and drew what was allotted him for the next week. The family had never eaten such food, and hardship was great. It consisted of fat meat, hard tack, a little flour and coffee. The meat had worms and the hard tack contained weevils. Dicey soaked the hard tack in water and fried it in

Battles raged all around the Read home, and the house, as other houses nearby, was turned into a hospital. Everyone was expected to do their part. The wounded, both North and South, were cared for by Dicey and her daughters. Everyone did what they could. Ida Barlow Trotter wrote articles for a newspaper in Winona and her story was later published in the Commercial Appeal a newspaper from MS, and later republished in the Vicksburg Sunday Post (5 April 1987)

At the end of the war, John filed a claim against the U.S. Government for property taken from him at his home near Edwards, MS. The claim, amounting to \$2,180.00 was

finally settled in 1916, long after John Read's death in 1871.

(Records may be found in Courthouse, Raymond, MS file # 646) The claim began in 1904 with a petition for letters. There were no heirs to John Read closer than grandchildren. In the course of the settlement all the grandchildren and their children, and place of residence were stated. Letters were sent out and came back with a signature. The documents are notarized and reveal the actual descendants of John Read. The case was closed Jan 9 1917, at which time those living descendents received small sums of money. This is a very valuable document in proving the descendents of the John Read family

In 1867, Dicey took one of her granddaughters, Ida Barlow (Trotter), by train to Carroll Co., MS. to visit her son Jesse Read. Dicey died while on this trip. She was taken home to Edwards, MS., and laid to rest in the Old Hinds County Cemetery there. She lies between her son, John D. Read, and 2 grandchildren, the children of her daughter Mary Elizabeth Read Hall. (Photos taken of the headstones by Helen Tice and

After Dicey's death, John sold his home at Edwards and went to Carroll Co., MS. to live with his son Jesse. He died there 1874 and is buried at Bluff Springs Cemetery, or as it is better known to residents of the area, "The Frog Pond". We are indebted to Helen Tice for this interesting account which was written in her story, "My Mississippi Roots".

On the 1860 census John and Dicey are listed as household #807, page124, at Edwards Depot in Hinds County MS. John is 65, a farmer worth \$10,000 real estate and \$19,000 personal estate. Living with he and Dicey are Ida Barlow age 6 and her brother Walter age 4 and the children's father A.K. Barlow age 50 who was born in N.C. and had property worth \$5000 and personal property of \$12,000

John Read was listed on the MS 1870 Census where he was found to be living with granddaughter Ida Barlow age 15 and Ida's 14 year old brother Walter. Winona P.O.CARROLL Co MS 1870 19 July pg 563. family 88. On same census two houses from John, family 86 we find John's son Jesse (age 47) born in Alabama, counted with his wife Nancy (age 43) and the children, Molly, Eliza, Allen, Marvin, Sidney and Victor. he following is the Obituary for John Read

NEW ORLEANS CHRISTIAN ADVOCATE, AUGUST 9, 1877

Bro. John Read is dead. Bro. Read was born Dec. 6, 1794, in Halifax Co., N.C. In early life he emigrated with his father, and settled in East Tennessee. He was a soldier with Gen. Jackson from 1812 to 1814, but when his country no longer demanded his services in war he returned to his home in Tennessee where he was soon after happily married to Miss Dicy Duke. Only a few months passed away before they professed religion and joined the Methodist Episcopal Church. This was perhaps as early as 1816. Bro. Read, after his marriage, first moved to N. Alabama; afterward to Missisippi, and settled in Madison county; thence to Hinds county, and settled near the present site of Edwards' Depot, where he lived for a number of years, elevating and blessing the community by his godly life. Some ten years ago his wife passed to her eternal reward. Bro. Read then removed to Carroll County, and spent the remainder of his long life at the pleasant home of his only son, where on the twenty-eighth of April, 1877, he bade adieu to earth, heard his Redeemer's call, and went to join that innumerable throng which came out of great tribulation, and have washed their robes and made them white in the blood of the lamb. Bro. Read was not a man of influence because of his talents and culture, but because of Christ within him. We do the subject simple justice to say that no one, to our knowledge, every exerted so wide and powerful an influence for good whose culture and natural ability did not surpass his. As steward and class-leader he was tried and true, ever holding up the hands of his pastor. He labored by the side of such men as Lane, Drake, Byrd, Light and Wiggins of precious memory, and others during his long illness, we he turn and in memory live again with the pioneers of Methodism in Mississippi. His house was a Methodist preaching-place more than fifty years ago. He loved to talk of the trials and triumphs of those days; and no less did he love to turn and, by an eye of faith, see his comrades from the battlements of heaven beckoning him on. He felt that he had many friends who would receive him into "everlasting habitation."

Bro. Read was confined to his room, and most of the time to his bed, for more than a year; but the grace of God was sufficent for him. We often visited this man of God in his last months, and never without profit toourselves. His only fear seemed to be that he was too anxious to go over and possess the goodly land, and via with angels in praising his blessed Lord.

One comment from this author about John Read. When his slaves were called to make a deposition during the long court case to settle what John felt was owed him from confisgations during the Civil War, they were asked their names, they replied,"Mr Read gave us our names." They were Stuart and Sterling Lewis.

William Francis Read appears as head of household on the 1850 free census which was taken in Hinds County on 26 of Nov 1850 at which time we believe that William was deceased. He is listed as 34 years old born in Ala and a planter by occupation, with property worth \$800. He is is household # 1145 M 432, roll372 and page 195.

Listed with William is his wife Maria L age 32 born in VA and the children all born in MS who are Charles W age 12, John J age 8, Joseph age 6, Elizabeth age 4 and Frances age 2. Also living with the family is Joseph M Dotson age 15 and born in TN.

According to the land records found in the Courthouse in Raymond MS William and Maria were having a difficult time with their property and it appeared as though they needed an infusion of funds. So when researching the family we leaped to the conclusion that William made an illfated trip to California to the Gold Rush as so many others were doing. Many persons were leaving MS at this time for CA. However there is some thought from unproved sources that say he accompanied his brother John Duke Read to a warmer climate for the latter's health. But instead William died of typhoid fever and John lived to return to MS where he died in 1853.

Jesse Read was the GGGrandfather of fellow researcher Helen Tice. The following is written by Helen Tice as she reveals the history of her forefather from her extensive research. He was a graduate of The Sharon Male Academy in Madison Co MS. On 1 June 1846 Jesse enlisted at Vicksburg, MS to fight in the Mexican War. He was mustered in 6 June 1846 at Benton MS, Jesse was part of Capt. Sharp's Company, First regiment MS Infantry, under command of Col. Jefferson Davis. However Jesse was never to see action. A training injury and illness due to exposure caused his early discharge, and made him eligible for a disability pension. he was discharged 9 June 1847 at New Orleans. Military records describe him as 5 Feet 9 inches tall, dark complexion, brown hair and hazel eyes.

He married Nancy Jane Gary in 1847, a daughter of West Gary and Elizabeth Steadman, in the parents home in Middleton, MS with the service performed by Baptist

Minister, James N Clinton.

They lived in Carroll Co, then moved to Hinds Co before the Civil War. Most of Jesse's property was lost in the general wreckage that followed the war. Thus the family moved back to Carroll Co, where he died and is buried next to his father in the

Old Bluff Springs Cemetery.

When the estate of Jesse's father was settled on Jan 7 1917, Jesse was already deceased but his children and their children were listed. Elizabeth (Lizzie) married Mr Peoples, but she was then deceased. Her children were Anderson, Gary, Nancy and Mrs Wade Forest. Mollie married Mr Tyson and she was deceased but left three daughters-Mrs Allie Amos, Eupors MS, Mrs Nannie Booth, Winona MS and Mrs Annie Lee Rogers, Cleveland MS. In 1876 Rosa's husband was in South America working, according to a letter he wrote from there. Unfortunately she died in 1878. It is not known to this author if her husband had returned by that time. But in 1880 the three small children were with the father's sister. They lived with her until Mallory the youngest was 6. At this time their father remarried Nebraska Carter and they all went to live with her.

An obituary clipped from a newspaper which could be the Burbank Daily Review where May was employed, gives the following information, "Funeral services for Mrs Nebraska Read, who died yesterday afternoon at her home, 528 North Santa Anita Ave, will be conducted Monday afternoon at 2:30 o'clock at the Fillbach chapel. The remains will be cremated and sent to Meridian, MS former home of the deceased, where they will be placed beside the grave of her husband.

Near relatives surviving Mrs. Read are the daughter Miss May Read, of 528 North Santa Anita Ave, two sisters, C.E. and May Carter, living in Hattiesburg MS, and one brother, Asa Carter, of Gulfport MS. The deceased was born in Augusta MS July 13, 1854 but she grew to maturity in Paulding, the same state, her family having moved to that place while she was young. Later she removed to Meridian, MS where she was united in marriage to Captain Charles W Read of the Confederate States navy. The couple shortly moved to New Orleans where the home was maintained until the death of Captain Read in 1890.

In 1920, Mrs Read moved from the south to CA, and the following year came to Burbank, where they have since resided."

Another clipping concerning the death lists Rev Roy O Youtz, as pastor of the

Christian church, conducting the service.

A further clipping probably from a MS paper states, "Ashes of the body of Mrs.

Nebraska Read whose death occurred in CA were interred in Rose Hill cemetery Friday morning, the prayer service being conducted by Rev Blanding Vaughan, pastor of South Side Baptist church. A large number attended the rites, including many relatives from Hattiesburg and members of the Winnie Davis chapter, United Daughters of the Confederacy, who attended in a body."

At some time after the death of her first husband Nebraska married a Mr May. A letter in the collection of Charles Read's papers, shows that Nebraska was married by 12 Oct 1894, since it was addressed to Mrs N. C. May. Then on June 20 1911 a petition


was granted so that she was authorized to resume the name of Read.

Charles' brother Joe wrote an article for "Our Heritage ", McComb, MS on September 1928 telling about Savez's adventures in the Confederate Navy. But he also wrote a story about the brothers and the newspaper. The following is an excerpt from the article. "He learned the printer's trade in vacations and in the afternoons when school was over, in the office of the Mississippian. Associating himself with a number of other boys in the office and about town he established a little paper called "Scraps of Young America", and he was at one time its editor. The boys took time about in this position. In one of the articles he aroused he ire of the editor of the "Vicksburg Sun". (this paper being noted for its fighting editors) who came up to Jackson with the intent of

calling him to account.

He attended an amateur performance given by "The Thespian Society" of which Read was a member, in company with a friend who told him he knew Read and would

point him out to him at the play.

The play was "Black Eyed Susan" and Read took the part of a sailor boy and when he appeared on the stage in his sailor suit he was pointed out. He was about 15 years old and small for his age. The editor of the Sun was very much chagrined and said he was looking for a man, and didn't come to Jackson to fight a boy!"

One other note from his daughter May Elizabeth born to his second wife was the fact that her father ran away as a boy and signed up on a sailing vessel. His family got him released and sent home. This note was made by May in handwriting on a typed

article about her father in the Dictionary of American Biography.

Charles William Read was a colorful member of the family. He entered Annapolis in 1856 to take his military training and just as he completed it, ending up number 25 in a

class of 25, the year was 1860, and the country was in turmoil.

When he heard that MS was involved in the War between the States, he was serving as midshipman on the United States frigate "Powatan", then stationed in Vera Cruz Mexico. Waiting until his ship docked back in New York, he resigned his commission and joined the Navy for the Confederates.

According to the records of the U.S. Naval Academy, his record is stated thus: Born in MS. Appointed from MS. Resigned as Midshipman, April 13, 1861. Acting master, July 12 ,1861 Lieutenant for the war, February 8, 1862. Second Lieutenant, October 23, 1862, to rank from October 2, 1862. First Lieutenant Provisional Navy, June

2, 1864 to rank from January 6, 1864

Lieutenant Read had an exciting career during the War. In summary he captured hwenty two vessels between 6 June and 27 June 1863. He was captured off Portland ME, June 27 1863 while trying to capture the twenty third vessel, the Caleb Cushing. In September 28, 1864 he was exchanged and paroled. Then participated in naval operations on the James River. He was commanding the C.S. Ram W.H.Webb when destroyed, near New Orleans, April 24, 1865, captured and then released at Fort Warren, July 24, 1865 on oath and parole of honor.

The following is a copy of a letter he wrote which is now found in the files of Gov.

Sharkey of MS to speed up his parole:

A typed letter (no doubt a copy) written by Charles W Read from Fort Warren,

Boston (prison) on June 28th 1865.

From the papers of Governor Sharkey (MA - Series E vol.69 Governor Sharkey

Dear Sir.

The close of the war finds me a prisoner of war here. As I am a graduate of the U.S. Naval Academy, I am excepted from the benefits of the President's Late Amnesty Proclamation.

On the 14th of May last I applied for the Oath of Allegiance to the U.S.: and on the 21st of the present month I made a written application to the President for permission to take the Amnesty oath. In making these applications I was actuated by a sincere desire to become once more a law abiding citizen of the United States.

I desire to return to Mississippi and live a peaceful life among my friends.

I graduated at the Naval School at Annapolis in June 1860. In February 1861 I was led to believe that Mississippi had ceased to be one of the United States and I felt it my duty to give up my profession and cast my fate with the State of my maternity. When hostilities commenced I accepted a commission in the Confederate Navy. At the end of the war I held the rank of First Lieutenant in said Navy.

I earnestly request that you will ask the President to grant me the Amnesty and

allow me to return home.

I have not seen you for so long that I suppose you have forgotten me. I beg leave to refer you to Mr B. Barksdale or Maj. F.S. Hunt.

I was appointed in the U.S.Navy by Hon. W.A. Lake of Vicksburg Very

In the book "Nine Men in Gray", by Charles L. Dufour the career of Charles W is written concisely and the book includes a picture of our hero while imprisoned in Fort Warren, MA. There is also an interesting account of the exploits of Charles after the war when he engaged in some questionable tactics in Columbia selling and then pirating a ship from both sides of a revolution.

However in May 2000 a letter has been found to survive, written to a relative in Nova Scotia from South America. It is dated 1878. The following is a transcription of a copy of the letter which was not fitted on the copy machine properly. Thus the words on the right margin of the document are unreadable. The owner of the letter has promised a better copy and transcription. But at the moment this is all that is available
